Following the issuance of demand letters, Bank of China, Bank of Beijing, Xiamen International Bank and Industrial Bank (the "Lending Banks") have restricted the remittance from the bank accounts of the subsidiaries of the Company in their banks in China. Approximately RMB 160 million (\$24.6 million) have been affected. The Company is negotiating with the Lending Banks.
